

STUDENT RIGHTS AND RESPONSIBILITIES

1. I have the **RIGHT** to learn at this school.
It is my **RESPONSIBILITY**:
 - ★ to listen carefully to instructions;
 - ★ to work quietly at my desk;
 - ★ to raise my hand to ask a question, tell about a concern, or if I need to leave the classroom.
2. I have the **RIGHT** to hear and to be heard.
It is my **RESPONSIBILITY**:
 - ★ not to talk or shout, and to avoid making loud noises, when others are speaking.
3. I have the **RIGHT** to be respected in this school.
It is my **RESPONSIBILITY**:
 - ★ to avoid teasing or bugging other people to hurt their feelings.
4. I have the **RIGHT** to be safe at this school and while traveling to and from school.
It is my **RESPONSIBILITY**:
 - ★ not to threaten, kick, punch, or physically harm anyone else;
 - ★ to report unsafe behaviours to an adult.
5. I have the **RIGHT** to privacy and to my own personal space.
It is my **RESPONSIBILITY**:
 - ★ to respect the personal property of others;
 - ★ to accept every person's right to privacy.



DRESS CODE

WEB with the WEB Parent Advisory Council, considers the classroom as a "place of business". Appropriate will be defined here as right and correct for the school setting and functions, conducive to learning, not distracting from or disruptive to the learning process, intimidating to others, make any other student or adult in the building uncomfortable. Students are expected to refrain from dress styles which promote, imitate or celebrate violence, intimidation, racism, sexism, hatred towards others, gang association, sex, or alcohol/drug use. Clothes should not display language which is sexual, explicit, defamatory or offensive to any members of the school community. In addition, footwear must be worn at all times for health and safety reasons.

Students or visitors to WEB who do not meet the dress code will be respectfully required to change into appropriate attire or asked to leave the property.

Responsible Student Use of Personal Digital Devices, School Technology, and District Network Services

Student use of personal digital devices (any device used to communicate and/or access the internet), school technology, and district networks at school is for educational purposes.

Students must abide by the school's Code of Conduct and procedures, as well as Central Okanagan Public Schools Policy 486: Student Use of Network Services and Digital Technologies.

Students will:

- Secure, power off and store personal digital devices during instructional (i.e. class time) and non-instructional time (i.e. breaks/lunch) at Elementary schools unless instructed by the Principal or school staff;
- Use personal digital devices during instructional time for instructional purposes and digital literacy skills as instructed by the Principal or school staff;
- Ensure personal digital devices are not used in areas where privacy is expected, such as restrooms and change rooms;
- Be permitted to use personal digital devices to support accessibility, accommodations, medical and health needs;
- Always take precautions to ensure online safety, privacy, and security;
- Treat others with respect and kindness when using digital devices and district network services;

Code of Conduct

A school's Code of Conduct is established to help maintain a safe, caring, and orderly environment for learning.

School Rights & Responsibilities

Some of the things we expect at our school and all school functions include:

- showing good manners;
- respecting self, others, & property;
- giving best effort at work & play;
- making safe choices;
- honesty;
- punctuality in attendance;
- using appropriate language;
- following school guidelines; and
- showing responsibility and leadership.

Our school has identified "Rights and Responsibilities" for all students and classroom expectations. These are the foundation of our Code of Conduct. The rights and responsibilities, as well as the classroom expectations, are created, taught, and reviewed at the beginning of every school year. They are also reviewed with students who make choices that intrude on another student's rights. The Code of Conduct is also posted on our website and throughout our school.



While most members of our school community conduct themselves in a positive and responsible manner, making poor choices, or not following our school's Code of Conduct, may occur.

A variety of strategies will be used to deal with events that occur—severity of the event, frequency of events, and student age/maturity are considered when determining appropriate consequences. Special consideration may apply to students with special needs who are unable to comply with expectations due to having a disability. **Whenever possible and appropriate, consequences will be corrective rather than punitive.**

Webber Road Elementary School promotes the values expressed in the BC Human Rights Code respecting the rights of all individuals in accordance with the law – prohibiting discrimination based on race, colour, ancestry, place of origin, religion, marital status, family status, physical or mental disability, gender, gender identity, expression or sexual orientation. **Behaviour or communication that discriminates based on any of the prohibited grounds listed will be treated seriously by our school.**

Minor Events (Incidents)

These actions disturb the positive and orderly school environment and include behaviours like:

- being in an out-of-bounds area
- Use of cell phones during instructional time
- misuse of washrooms or playground items
- misuse of playground items
- playing unsafely (ie. rough play)
- poor lunch manners
- chewing gum
- rudeness to other students (name-calling)
- pushing and shoving in a line-up
- running while indoors
- littering (inside and outside school)
- disruption of instruction/learning
- displaying behaviours of a romantic or sexual nature

Consequences (progressive):

- warning
- problem-solving conversation/reflection sheet
- review of expectations
- a time-out with supervising staff
- school service
- loss of privileges/restitution



Major Events (Incidents)

Minor repeated incidents will be treated as a major incident. This level of misbehaviour may also include:

- lying
- swearing
- wilful damage/disrespectful of school property
- leaving school grounds without permission
- stealing
- defiance towards staff
- bullying (eg. intimidation, racial slurs)

Consequences (progressive):

- problem-solving conversation
- school/community service
- contract created
- parent/guardian contacted
- in-school/out-of-school suspension

Unacceptable Events (Incidents)

These behaviours are highly disruptive. Repeated major incidents will be dealt with as unacceptable. These incidents include:

- fighting (violence)
- throwing dangerous items (eg. rocks, snowballs, etc.)
- major theft or vandalism
- possession of or use of weapons
- extreme non-compliance with staff
- drugs/alcohol/tobacco at school

Consequences:

- in-school/out-of-school suspension
- 1-10 day Suspension or Indefinite Suspension (away from school, at the discretion of the principal)
- legal intervention (ie. R.C.M.P.)

Notification

Depending on the severity of the infraction, parents of student offenders and student victims may be notified. The school will also inform other parties as necessary. For example, in case of illegal activity, the R.C.M.P. will be notified, or if the safety or well-being of a child is in question, the Ministry of Children and Families will be notified.
